The Bureau of Fisheries and Aquatic Resources 6, through the RA No. 11975 General Appropriations Act, FY 2024 intends to apply the sum of *Two Million Six Hundred Thirty-Eight Thousand Four Hundred Eighteen Pesos Only (₱ 2,638,418.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of Milkfish Fingerlings Distribution and Various Inputs for the Milkfish Fry Bank Project Under the National Fisheries Program for CY 2024** individually described as follows:
